1. Database Forms and Views

Each Lotus Notes database possesses a series of forms and views, which are accessible externally via web browsers and internally via Lotus Notes, granted appropriate ACL access. The following documents each form layout, form content, and views currently used within the Lotus Notes database.

1.1 Common forms and fields for all Databases

Every form in each database, excluding the Common Elements database, contains the following:

ProgramTopic Listings Field {Hidden Field}

This field contains the program and topic value combination(s) for a document. This is a text field which is populated when a new program and topic value combination is entered into the Subject Detail subform. Values will be of the format : [Program1] \ [Topic1] ; [Program2] \ [Topic2].

SubForm Name : Subject Detail Subform

The Subject Detail Subform, which is to appear at the top of a form, is only visible internally within Lotus Notes when the document is being created or in edit mode. The entire contents of this form are to be displayed in a non-editable section. Users populate and modify the fields in this subform through the use of a popup window; therefore, users cannot edit the subform. This subform is a collection of the following fields :

- Program Field - This field contains the name of the SFA program which the document references. This is a text field.
- Topic Field- This field contains the name of topic under a known SFA program which the document references. A topic is a further refinement of a particular program issue. This is a text field.

Subject Detail SubForm Action Bar Item : Program Topic Button (excluding Common Elements Database)

This button appears on the action bar for the subject detail subform. This button allows the user to populate and modify the contents of the Subject Detail subform. The button is visible when documents are new or in edit mode. This button is not visible to web clients.

Form Name : ProgramTopic

It displays to users in a pop-up window when the Program/Topic Action Bar button is clicked. It is through this window that users select Program and Topic combinations with which a particular document is associated.

SubForm Name : Posting Detail Subform

The Posting Detail Subform is placed at the bottom of a form, is only visible internally within Lotus Notes. The entire contents of this form are to be displayed in a non-editable section. This subform is a collection of the following fields :

- Posted By Field - This field contains the name of the editor responsible for making the document available via Lotus Notes. This field is to be visible internally (not via a web browser) only. This is a text field which Lotus Notes populates based upon the common name of the current user id. For location of this field, reference the particular form layout for the database in question. This field will not be editable at all.

- **Posted Date Field**- This field contains the timestamp for when the document became available via Lotus Notes. This field is to be visible internally (not via a web browser) only. This is a date and time field which Lotus Notes populates based upon the common name of the current user id. For location of this field, reference the particular form layout for the database in question. This field will not be editable at all. This field will display as a calendar date in long format (e.g., January 27, 1994).

**View Action Bar Item : Exit Action Button
(excluding Common Elements Database)**

This button closes the current window. This button is not visible to web clients.

**View Action Bar Item : Edit Document Action Button
(excluding Common Elements Database)**

This button opens the currently selected document in edit mode. The visibility of this document is based on having the appropriate access to the database. This button is not visible to web clients.

**View Action Bar Item : Create Document Action Button
(excluding Common Elements Database)**

This button composes a new document in the database. In instances where a document can be created by more than one form, a popup box will be displayed for the user to select which form to use. The visibility of this document is based on having the appropriate access to the database. This button is not visible to web clients.

**View Action Item : Delete Document Action Button
(excluding Common Elements Database)**

This button deletes the selected document(s) in the database. The visibility of this document is based on having the appropriate access to the database. This button is not visible to web clients.

1.2 Accrediting Agencies Database Forms and Views

Form Name : Accrediting Agencies

In addition to any common form field definitions, the Accrediting Agencies form is comprised of the following fields:

- **Publication Date** - This field contains the publication date of the document. This is date/time field which users populate upon creating or editing a document. This field is only displayable on documents which are new or are being edited.
- **PublicationDateForDisplay** - This field contains the contents of the publication date field. The field displays in the format Mmmm CCYY (e.g., January 1993). This field is only visible when a document is not being newly created or edited.
- **Section Order** - This field orders the section. Default is 1.
- **Section** - This field contains the section name to which the document belongs. This is a text field which the user populates upon document creation.
- **Body Of Text Field** - This field contains the contents of the document body. This is an editable rich text field capable of supporting attachments and embedded formatted documents. The user populates this field upon document creation.

View Name : Specific Publication Date

This is a collection of all Accrediting Agencies ("Nationally Recognized Accrediting Agencies") documents for a particular publication date. The view should display as follows:

1.3 Announcements Database Forms and Views

Form Name : Announcements

In addition to any common form field definitions, the Announcements form is comprised of the following fields:

- Publication Date -This field contains the document publication date. This is a date and time field which the user will populate. This field is visible upon document creation or editing a document.
- PublicationDateForDisplay - This field displays the contents of the PublicationDate field as a calendar date in long format (e.g., January 27, 1994).
- Author - This field contains the title of the document author. The system user/editor is not the document author. The user will populate this field from a fixed list of values. Valid Values are :

- Summary Field - This field contains the summary of the Announcements content. This is an editable text field. The user populates this field by entering a stream of text. For the location of this field, reference the form layout for the Announcements database.
- Body Of Text Field - This field contains the contents of the entire Announcement. This is an editable rich text field capable of supporting attachments and embedded formatted documents. The user populates this field upon document creation.

View Name : Recent Announcements

This is a collection of all announcement documents which contain a publication date within 30 days of the current system date. The view should display as follows:

1.4 Audit Guide Database Forms and Views

Form Name : Audit Guide

In addition to any common form field definitions, the Audit Guide form is comprised of the following fields:

- Audit Guide Type - This field contains the type of the document. Valid values are :

Audit Guide for Lenders
Audit Guide for Schools

- Publication Date - This field contains the publication date of the document (month and year only.) The field should display in long date format : Mmmm, YYYY.
- Section Order - This field orders the section. Default is 1.
- Section Number- This field contains the section number and title to which the document belongs. This is a text field which the user populates upon document creation. The field should be of the format : (I, II, III - n) -- Xxxxxx (e.g., III). There were also be values such as "Contents," "Introduction" and "Appendix"
- Section Title – Title of Section.
- Page Numbers - This field contains the page number(s) of the document from the printed text. This is a text field which the user populates upon document creation. The field should be all numeric with the inclusion of the following characters: , - (e.g., 2,3 or 2-5).
- Body Of Text Field - This field contains the contents of the document body. This is an editable rich text field capable of supporting attachments and embedded formatted documents. The user populates this field upon document creation.

View Name : Specific Audit Guide Type (values: Audit Guide for Schools; Audit Guide for Lenders)

This is a collection of all Audit Guide documents for a particular Audit Guide Type. The view should display as follows:

1.5 The Blue Book Database Forms and Views

Form Name : Blue Book

In addition to any common form field definitions, the Blue Book form is comprised of the following fields:

- Publication Date- This field contains the publication date of the document (month and year only.) The field should display in long date format : Mmmm, YYYY.
- Chapter Order - This field orders the Chapter. Default is 1.
- Chapter Number - This field contains the chapter number and chapter title to which the document belongs. This is a text field which the user populates upon document creation.

The field should be of the format : (1-n) -- Xxxxxx (e.g., 1 -- Student Eligibility).
Values also include "Contents," "Introduction," "Appendix," "Index"

- Chapter Title – Description of Chapter
- Section Order - This field orders the section. Default is 1.
- Section Number - This field contains the section number and section title to which the document belongs. This is a text field which the user populates upon document creation. The field should be of the format: (1-n) -- Xxxxxx (e.g., 1 -- Non-Campus-Based Program Reporting).
- Section Title – Description of Section
- Page Numbers - This field contains the page number(s) of the document from the printed text. This is a text field which the user populates upon document creation. The field should be all numeric with the inclusion of the following characters: , - (e.g., 2,3 or 2-5).
- Body Of Text Field - This field contains the contents of the document body. This is an editable rich text field capable of supporting attachments and embedded formatted documents. The user populates this field upon document creation.

View Name : By Publication Date (e.g., July, 1995)

This is a collection of all Blue Book documents. The view should display as follows :

1.6 Common Elements Database Forms and Views

Form Name : Citations {Internal Use Only}

Documents created by this form are only to be visible by internal Lotus Notes users which possess appropriate ACL access (i.e., Manager, Designer). Only Lotus Notes agents possess the ability to create documents with this form. Documents created with this form are not to be viewed from the web.

- As Of Date - This field contains the "as of" date of the citation's document. This is a date/time field which is populated by Lotus Notes agents when a Regulation Compilation document or Higher Education Act document is created.
- Part - This field contains Part number or Part Letter depending on the value in the Citation Type Field. If the Citation Type field has a "1" value then this field will contain the Part letter (e.g., "A", "B"). Otherwise this field will contain a Part number (e.g., 86, 693). This is a text field which is populated by Lotus Notes agents when a Regulation Compilation document or Higher Education Act document is created.
- Part Title - This field contains the title associated with the Part. This is a text field which is populated by Lotus Notes agents when a Regulation Compilation document or Higher Education Act document is created.
- SubPart - This field contains the subpart associated with a Regulation Compilations document. This field will only be populated if the Citation Type field does not possess a value of "1". This is a text field which is populated by Lotus Notes agents when a Regulation Compilation document or Higher Education Act document is created.
- Subpart Title - This field contains the title associated with the subpart. This is a text field which is populated by Lotus Notes agents when a Regulation Compilation document or Higher Education Act document is created.
- Section - This field contains the section number of a document citation. This is a text field which is populated by Lotus Notes agents when a Regulation Compilation document or Higher Education Act document is created.
- Section Title - This field contains the title associated with the Section. This is a text field which is populated by Lotus Notes agents when a Regulation Compilation document or Higher Education Act document is created.

- **Subsection** - This field contains the subsection letter of a document citation. This is a text field which is populated by Lotus Notes agents when a Regulation Compilation document or Higher Education Act document is created.
- **Paragraph** - This field contains the paragraph number of a document citation. This is a text field which is populated by Lotus Notes agents when a Regulation Compilation or Higher Education Act document is created.
- **Subparagraph** - This field contains the subparagraph of a document citation. If the Citation Type field has a "1" value then this field will contain the subparagraph uppercase letter (e.g., "A", "B"). Otherwise this field will contain a lowercase roman numeral (e.g., ii, ix). This is a text field which is populated by Lotus Notes agents when a Regulation Compilation document or Higher Education Act document is created.
- **Division** - This field contains the division of a document citation. If the Citation Type field has a "1" value then this field will contain the division lowercase roman numeral (e.g., i, vii). Otherwise this field will contain an uppercase letter (e.g., "A", "J"). This is a text field which is populated by Lotus Notes agents when a Regulation Compilation document or Higher Education Act document is created.
- **Clause** - This field contains the clause of a document citation. If the Citation Type field has a "1" value then this field will contain the subparagraph uppercase roman numeral (e.g., III, IX). Otherwise this field will contain a number (e.g., 2, 3). This is a text field which is populated by Lotus Notes agents when a Regulation Compilation document or Higher Education Act document is created.
- **Citation Type** - This field contains a number which indicates whether the citation refers to a Higher Education Act document or a Regulations Compilations document. This is a keyword field with the following values:

Regulation Compilation
Higher Education Act

The default value is "Regulation Compilation". Lotus Notes agents populate this field when a Regulation Compilation document or a Higher Education document is created.

- **Internal Citation Field** - This field contains the internal citation representation for the specified document citation. This is a text field which is populated by Lotus Notes agents when a Regulation Compilation document or Higher Education document is created.
- **Citation Lookup Flag** - This field denotes whether this citation exists as a document or is for the purpose of reference. This is a keyword field with the following values :

Valid Citation
Reference

The default value is "Valid Citation". Lotus Notes agents populate this field when a Regulation Compilation document or a Higher Education document is created; or, when a citation document for the purposes of reference is created.

- **Referenced Citation Document Field** - This field contains the unique document ID of the Regulation Compilation or Higher Education Act document to which the document citation refers. Lotus Notes agents populate this text field when a Regulation Compilation document or a Higher Education document is created.
- **Update Federal Registers** - This field contains the unique document ID's of Federal Register documents which reference this citation. Lotus Notes agents populate this text field when a Federal Register document(s) reference this citation.

Form Name : ProgramTopic Form {Internal Use Only}

Documents created by this form are only to be visible by internal Lotus Notes users which possess appropriate ACL access (i.e., Manager, Designer). Only Lotus Notes agents possess the ability to create documents with this form. Documents created with this form are not to be viewed from the web.

- Program - This field contains the program name with which a document can be associated. This is a text field which is populated by Lotus Notes agents when a ProgramTopic form is created or modified.
- Topic - This field contains the topic under a particular program with which a document can be associated. This is a text field which is populated by Lotus Notes agents when a ProgramTopic form is created or modified.
- Link Flag - The contents of this field indicates whether a ProgramTopic document possess links to other documents. This is a keyword field with the values :

"Yes"
"No"

The default value is "Yes".

- Link Body - This field contains the link(s) to documents which possess the same program and topic field combination as the ProgramTopic document. This is a text field which is populated by Lotus Notes agents.
- Reference Flag - The contents of this field indicates whether the ProgramTopic document is used for application reference (for lookups) or possesses document links. Valid Values are :

Link
Reference

The default value is "Link".

Form Name : Modify ProgramTopic Form

Users with the appropriate ACL access role (i.e., [ProgramTopic Editor]) use this form to modify the Program and Topic combination lists which all of the databases reference.

** Please Note **

The application is to be initialized with the following Program and Topic combinations to facilitate programmatic lookup. The Program and Topic combinations must be created (entered into the application) using the Modify ProgramTopic Form. The current listings as of this writing can be found in "IFAP Program and Topic Table" reference document.

- Program - This field contains the program name with which a document can be associated. This is a text field which the user populates from a fixed list of values obtained from the "(Reference \ ProgramTopic View)".
- Topic - This field contains the topic under a particular program with which a document can be associated. This is a text field which the user populates from a fixed list of values obtained from the "(Reference \ ProgramTopic View)".
- SaveOptions - This computed numeric field contains the value of "0" which indicates that documents created by the Modify ProgramTopic form are never to be saved.

Modify ProgramTopic Form: Add

This button creates a ProgramTopic document with a new Program and Topic combination for reference by other databases.

Modify ProgramTopic Form: Edit

This button edits an existing Program and Topic combination values. Change in the combination values is propagated throughout all of the effected documents.

Modify ProgramTopic Form: Delete

This button deletes an existing Program and Topic combination. The combination values in all documents which possess the same combination.

Modify ProgramTopic Form: Exit

This button closes the form.

Form Name : Counselor's Handbook

In addition to any common form field definitions, the Counselor's Handbooks form is comprised of the following fields:

- Edition - This field contains the type of Counselor's Handbook. There are two possible values to this field:

Postsecondary
High School

- Award Year - This field contains the valid school year which pertains to the document. This is a text field which the user populates upon document creation. The field should be of the format: CCYY - CCYY (e.g., 1994 - 1995).
- Part Order- This field orders the section. Default is 1.
- Part Title - This field contains the part title to which the document belongs. This is a text field which the user populates upon document creation. The field should be of the format :Xxxxxx (Student Eligibility).
- Page Numbers - This field contains the page number(s) of the document from the printed text. This is a text field which the user populates upon document creation. The field should be all numeric with the inclusion of the following characters: , - (e.g., 2,3 or 2-5).
- Section Order - This field orders the section. Default is 1.
- Section Number - This field contains the section number to which the document belongs. This is a text field which the user populates upon document creation. The field should be of the format: (1-n) .
- Section Title - This field contains the section title to which the document belongs. This is a text field which the user populates upon document creation. The field should be of the format: Xxxxxx (e.g., Maryland Students Only).
- Body Of Text Field -This field contains the contents of the document body. This is an editable rich text field capable of supporting attachments and embedded formatted documents. The user populates this field upon document creation.

This is a collection of all Counselors' Handbooks documents for a particular award year. The view should display as follows:

- PublicationDateForDisplay - This field displays the contents of the PublicationDate field as a calendar date in long format (e.g., January 27, 1994).

- Award Year - This field contains the valid school year which pertains to the document. This is a text field which the user populates upon document creation. The field should be of the format: CCYY - CCYY (e.g., 1994 - 1995).
- Publication Type - This field contains the publication Type. There are four possible values to this field:

FISAP Form/Instructions
Notification of Campus-Based Awards
Perkins Cohort Default Rate Booklet
Notifications

- FISAP Part - This field contains the FISAP type. There are four possible values to this field:

Instruction Booklet
Form
Coverletter
OSFA Contracts

- Part Order - This field contains the order number:
- Awards/Default Part -
- Notifications Subject -

1.9 Dear Colleague Letters/Action Letters Database Forms and Views

Form Name : Dear Colleague Letter

In addition to any common form field definitions, the Counselor's Handbooks form is comprised of the following fields:

- Publication Date - This field contains the publication date of the document. This is a date/time field which Lotus Notes computes based on the value of the DCL Publication Date field (i.e., has the same value as the DCL Publication Date field). The field will be displayed only upon reading the document. The field should display in short date format : Mmmm YYYY.
- DCL ID - This field contains the Dear Colleague Letter (DCL) ID of the document. This is a text field which Lotus Notes computes based on an algorithm using values from the DCL Type field, DCL No field, and the DCL Publication Date field. The field will be displayed only upon reading the document. The field display and contents is dictated by the following algorithm:

The DCL ID should display as:
 {DCL Type Field} "-" { 2-Digit Year of the DCL Publication Date Field} "-"
 {DCL Number Field} except where the DCL Type is "G", "L", or "S", the DCL ID should display as;
 {2-Digit Year of the DCL Publication Date Field} "-" {DCL Type Field} "-"
 {DCL Number Field}

- DCL Type - This field contains the document type of the Dear Colleague Letter. This is a text field which the user populates from a fixed list of values. Valid values are : GEN, CB, ANN, L, P, S, G, POL, SPEC, SG, and SYS. This field will display only upon the creation and editing of a document.
- DCL No - This field contains the sequential number assigned within each document type. This is a text field which the user populates upon document creation. This field will display only upon the creation and editing of a document.
- DCL Publication Date - This field contains the document publication date. This is a date/time field which the user populates upon document creation. This field will display only upon the creation and editing of a document.
- Action Letter Flag - This field indicates whether a particular Dear Colleague Letter is also an Action Letter. This is a yes/no field which the user populates upon document creation.
- Award Year - This field contains the valid award year which pertains to the document. This text field is only visible and available for population when the Action Letter Flag field is set to "Yes". The field should be of the format: CCYY - CCYY (e.g., 1994 - 1995).
- Action Letter Number - This field contains the sequential number assigned to the Action Letter. This numeric field is only visible and available for population when the Action Letter Flag field is set to "Yes".
- Summary Field - This field contains the summary of the Dear Colleague Letter/Action Letter content. This is an editable text field. The user populates this field by entering a stream of text. For the location of this field, reference the form layout for the Dear Colleague Letters database.
- Body Of Text Field - This field contains the contents of the document body. This is an editable rich text field capable of supporting attachments and embedded formatted documents. The user populates this field upon document creation.
- Attachments/Enclosures - This field contains all attachments associated with the document. This is an editable rich text field capable of supporting attachments and embedded formatted documents. The user populates this field upon document creation.

View Name : Recently Published Letters - [last thirty days]

This is a collection of all recently published letters (all Dear Colleague Letters created in the last 30 days). The view should display as follows:

View Name : DCL Specific Publication Year (e.g., 1995)

This is a collection of all Dear Colleague Letters for a particular publication year. The view should display as follows:
