In addition, it provides a technical resource of Title IV management responsibilities that are shared between various administrative offices in a school. FAA Access	<p>Financial aid administrators and other authorized users can use FAA Access to CPS Online to view FAFSA processing results for students who listed their school code on the FAFSA or who have provided their Data Release Number (DRN).</p> <p>Using FAA Access, FAAs can transmit and correct applicant data, reapply for financial aid for their students, and transmit electronic signatures for applicants and their parents.
