1 Introduction

1.1 Summary

The EAI team provides maintenance support for application teams after the rollout of the application interface. This report documents the application interface maintenance services provided by the EAI Release 3.0 team including software upgrades and issue troubleshooting and resolution. This report will define the services rendered during the month of September 2002.

2 EAI Interfaces

EAI Interfaces maintained during this period include:

Direct Loan Servicing System (DLSS)-eServicing

The Direct Loan Servicing System (DLSS) tracks loans received from the booking process, through the in-school period, and through payoff from either the borrower or the Department of Education (defaulted loan).

Student Aid Internet Gateway (SAIG)

The SAIG Secure Portal writes the School information to the COD mailbox. This interface enables the schools (via bTrade) to send and receive data to and from COD.

A detailed description of SAIG issues can be referenced in the attached issue resolution matrix section 200.

Common Origination and Disbursement (COD)

COD is the key modernization initiative for the Schools Channel. The COD system redefines aid origination and disbursement processes for Pell Grants and Direct Loans, and provides optional common reporting opportunities for campus-based programs.

Financial Management System (FMS)

The Financial Management System (FMS) manages all financial transactions.

Post-Secondary Education Participant System (PEPS)

This interface transfers schools eligibility data from the Post-secondary Education Participant System (PEPS) to eCampus Based (eCB).

Electronic Campus Based System (eCB)
